


B1 What is the Decision?	To make a Public Space Protection Order (PSPO) for the purpose of implementing dog control powers.
B2 What are the reasons for the Decision?	<p>The Council's current Dog Control Orders will cease to have effect in October 2107 under the provisions of the Anti Social Behaviour, Crime and Policing Act 2014 ("the Act"). The PSPO will incorporate the existing dog controls as well as additional controls, the need for which has been identified following consultation.</p> <p>Under section 59 of the Act, the Council can make a PSPO if it is satisfied on reasonable grounds that two conditions are met.</p> <p>The first condition is that—</p> <p>(a) activities carried on in a public place within the authority's area have had a detrimental effect on the quality of life of those in the locality, or</p> <p>(b) it is likely that activities will be carried on in a public place within that area and that they will have such an effect.</p> <p>The second condition is that the effect, or likely effect, of the activities—</p> <p>(a) is, or is likely to be, of a persistent or continuing nature,</p> <p>(b) is, or is likely to be, such as to make the activities unreasonable, and</p> <p>(c) justifies the restrictions imposed by the notice.</p> <p>The prohibitions and requirements to be imposed by the PSPO are reasonable to impose in order—</p> <p>(a) to prevent the detrimental effect referred to in subsection (2) from continuing, occurring or recurring, or</p> <p>(b) to reduce that detrimental effect or to reduce the risk of its continuance, occurrence or recurrence.</p>

<p>1.1. The power to make Public Space Protection Orders is derived from the Anti Social Behaviour, Crime and Policing Act 2014 ("the Act"). Public Space Protection Orders have effect for a period of three years. There is provision for a PSPO to be extended for a further three years, and on more than one occasion.</p>	
<p>1.2. The Council has satisfied itself that the conditions stipulated at section 59 (2) and s59 (3) of the Act are met and has consulted with the Police, the Police and Crime Commissioner and other bodies. The Council is also satisfied that the prohibitions and requirements imposed by the PSPO are reasonable measures to deal with the anti-social behaviour identified.</p>
