## 272/22 REVENUE AND CAPITAL OUTTURN REPORT 21/22

The report of the Head of Service (Sal Khan) on the final outturn position in relation to the Council's revenue budget, capital programme or expenditure and treasury management activities was considered. The following appendices had been circulated with the report:

- Appendix A Variances against Budget at Outturn 2021/22;
- Appendix B Summary of Capital Expenditure against Programme 2021/22;
- Appendix C Investments at 31st March 2022;
- Appendix D Revenue budget carry forward requests 2021/22 outturn;

Cabinet noted that the budget for 2021/22 of £13.371m includes a corporate provision of £1.3m towards Covid19 pressures and was balanced by taking into account the £1.1m from reserves. This recognised that there was a high degree of uncertainty and potential volatility with the budgets. The report highlighted that there had been some significant budgetary pressures against the pre Covid19 service budgets but also some windfall income streams and savings. This meant that after taking into account corporate budgets, including the provision of Covid19 pressure, there was an overall contribution to reserves of £0.4m at Outturn.

## 273/22 <u>END OF YEAR CORPORATE PLAN PERFORMANCE</u>

Cabinet also considered that as in previous years it was resolved to change the reporting status of the Amber targets in the end of year report to Red. This approach gives a year end outturn of 94.26% Green and 5.74% Red.
