BACKGROUND INFORMATION

There does not appear to be any publicly available official record from the <u>coroner's inquest</u> itself, so details contained in the <u>Express</u> Newspaper have been used to produce the below timeline. The details from the Express are in *italic font* as they cannot be verified, the details provided by Housing Options or YMCA are in **bold** font.

March 2021

• The Winters could no longer pay the rent on their home in Oak Street, Burton so they left most of their belongings behind and moved in with Mr Winter's family.

June 2021

- 1st Rough Sleeper Sweep conducted by the Outreach Team.
- 1st Family disagreements lead to the Winters moving out. They then started living in a tent in and around Burton upon Trent, relying on food banks to eat.
- 15th Rough Sleeper Sweep conducted by the Outreach Team.
- 20th The Winters try to return to living with Mr Winter's family, but are not allowed back.
- 22nd Response to report of possible rough sleepers in Branston (email and outcome attached).
- 24th Everything comes to a head when struggling to sleep, and Mr Winter says his wife "exploded", telling him she had had enough of their living arrangements. Mrs Winter then walked off carrying two bags.
- 29th Rough Sleeper Sweep conducted by the Outreach Team.
- 29th Mr Winter found his wife dead in a wooded copse near a children's playground at The Washlands area.

July 2021

- 2nd Mr Winter walked to Burton Police Station to report his wife's death. Mr Winter was arrested on suspicion of murder, but later cleared of any wrongdoing.
- 5th Call from the Police to source temporary accommodation on Mr Winter's release from custody. There had been no prior contact to the Housing Options Team either from or about the Winters. Accommodation was provided and Mr Winter was successfully moved on in short order.

Possible Concerns Identified

The couple were not found on the 'sweeps' conducted by the Rough Sleeper Outreach Team.

• The sweep attends hotspots and areas where they have been recent reports (as indicated by the response to a sighting in the email dated 22nd June). It is possible that people who are well concealed, or are making an effort not to be found will not be located. Mr Winter is reported as stating that the couple moved their tent periodically, 'in and around' Burton which would make them more difficult to locate. It should be noted that the location where Mrs Winter was found has not been identified as an area where they camped, either once or at all.

Mr Winter said the couple relied on food banks.

 The YMCA record the names of people using the food bank and requests ID where possible in order to monitor usage and offer assistance where necessary. There is no record of the Winters. There are of course a number of <u>alternative 'food bank' type establishments</u> in Burton which the Winters may have been utilising.

Mr Winter is reported as stating that the couple had often been asked to leave the areas they were camping.

- This statement is difficult to understand. The Police do not move people on in general, they would call Housing Options including the Out of Hours Service. Individual land owners may ask someone occupying their land to depart, but this would certainly not be commonplace.
- The Open Spaces Team do not systematically record contact with rough sleepers / sightings to tents, but there is a strong collaboration with Housing Options and a long established practice of reporting such contacts appropriately to secure assistance for the individuals affected. This collaboration applied in the same way to Civil Enforcement who report into the Housing Options Team as necessary.
