## **Question received from Councillor S Sankey**

Uttoxeter and surrounding area is short of high quality sports facilities. So it is excellent news that the sports hub on the quarry land near Uttoxeter is progressing. This is an initiative that is supported by all parties. So it was surprising that the cabinet member for regeneration indicated at a public meeting on the 10 September that he didn't want the sports hub in the proposed location. What is the administrations preferred site?

## Response by the Cabinet Member for Tourism and Cultural Development Councillor P Walker

Cabinet approved "the development of the Sports Hub in partnership with SFA (the quarry site), formally allocating the proposed £1.7 million funds into the project" and subsequently delegated "authority to the Cabinet Member for Tourism and Cultural Development in consultation with the Leader of the Council, Leader of the Opposition and the Chief Executive for allocating these funds".
