I understand that I will continue to be treated as the Designated Premises Supervisor until the requirements of A or B above are complied with.

I understand that I am obliged to direct you, as Premises Licence Holder, to send, within 14 days of receiving this Notice, to The Licensing Department, East Staffordshire Borough Council, The Town Hall, King Edward Place, BURTON UPON TRENT, DE14 2EB, the original Premises Licence and Summary or, if that is not practicable, a statement of the reasons for failing to do so.

A person commits an offence if he/she fails, without reasonable excuse to comply with a Direction given to him/her under Section 41 (4) (B) of the Act. A person guilty of an offence is liable on Summary Conviction to a fine not exceeding Level 3 on the Standard Scale.

For your information please note that no supply of alcohol may lawfully be made under the Premises Licence at a time when there is no Designated Premises Supervisor in respect of the Premises Licence. You should therefore consider whether it is appropriate to make an immediate Application, under Section 37 Licensing Act 2003, to Vary the Premises Licence to specify a different individual with a Personal Licence as the new Premises Supervisor and request that the Variation applied for should have immediate effect.
